
“NOTIFICACIÓN DEL IRS SOBRE EL NÚMERO DE IDENTIFICACIÓN PERSONAL PARA PROTECCIÓN DE LA IDENTIDAD” / “IRS NOTICE FOR IDENTITY PROTECTION PERSONAL IDENTIFICATION NUMBER (IP PIN)”

Queremos llamar la atención a todos nuestros clientes que durante el principio de este mes de enero 2025, el IRS ha estado enviando a los contribuyentes la **Notificación CP01A** relacionada a la asignación de un **Número de Identificación Personal para la Protección de la Identidad**, por sus siglas en inglés, **IP PIN**. Es importante que esta carta sea guardada en un lugar seguro y nos las envíen por correo electrónico ya que el número es necesario para la preparación de la planilla federal 2024 y/o cualquier radicación de las Formas 1040 corriente o de años anteriores que se someta a partir de enero de 2025. El no incluir este número podría traer como consecuencia que el IRS rechace o retrase el procesamiento de su planilla.

We would like to bring your attention of all our clients that during the beginning of this month of January 2025, the IRS has been sending taxpayers **Notice CP01A** related to the assignment of an **Identity Protection Personal Identification Number (IP PIN)**. It is important that this letter be kept in a safe place and sent to us by email since the number is necessary for the preparation of the 2024 federal tax return and/or any filing of the current or prior year Forms 1040 that is submitted during the calendar year beginning in January 2025. Failure to include this number could result in the IRS rejecting or delaying the processing of your tax return.
