3RD ESTIMATE TAX PAYMENT FOR THE 2024 PERSONAL PROPERTY TAX RETURN

The Estimate Tax Payments must be made only via the internet through the CRIM portal: <https://emueble.crimpr.net>

It is important to make estimated payments based on 100% of the tax paid in 2023 to benefit from the 5% discount when filing the return. Failure to make all CRIM estimated payments on time and in full will lose the discount and will be subject to penalties of 10% for each term not made.

Please, verify the emails we sent to our clients for the payment of the first installments and/or the instructions letters of the 2023 returns.

4TH & LAST ESTIMATE TAX PAYMENT

After the 3rd installment on **February 15, 2025**, the last 2023 Estimate Personal Property Tax Payment must be made on the following date:

- **May 15, 2025 (with the filing of the return or extension)**
